**Booth Fees are \$200.00 and are non refundable. Fees must be received by the JFA by April 15, 2011. Accepted form of payment will be a money order and must be paid in full (no deposits will be accepted).**

1. Commercially manufactured (buy/sell) items are strictly prohibited.
2. Exhibitor hours are from 9:00AM to 6:00PM on Saturday, May 28, 2011 and 9:00AM to 5PM on Sunday, May, 29, 2011.
3. You must check in with JFA Craft Booth Coordinator prior to setting up to pick up your parking permit, trailer tags and other information required for the weekend.
4. Gates will open to Exhibitors at 7:00AM on Saturday, May 28<sup>th</sup> and 7:30AM on Sunday May 29<sup>th</sup>.
5. Security will not be provided for Craft Booths between the hours of 7:00PM and 7:00AM on Saturday night.
6. Booth spaces are 15' x 15'.
7. No changes will be made the weekend of the festival.
8. This is an outdoor festival. Exhibitors must provide their own shelter, chairs and display materials. Please come prepared.
9. Special parking will be provided for Exhibitors.
10. Exhibitors are responsible for paying state sales tax (4%) and parish sales tax (4.5%).
11. No pets or animals are allowed on the festival grounds.
12. The JFA reserves the right to refuse space to applicants for any reason, including not meeting proper qualification for festival participation. Only original handcrafted items will be allowed. Items must be crafted by the Exhibitor. Items must be accepted by the JFA as listed on your application. You will be notified of any rejection of items. Each applicant must submit photographs and describe their product in detail – these items must be attached to your application and sent in at the same time as your application fee. Refunds of application fees will only be made if items/craft booth is rejected by the JFA and participation at festival is not allowed.
13. The JFA reserves the right to make changes to the Exhibitor booth layout at any time.
14. Gas powered generators are strictly prohibited on the festival grounds.
